#### **About the environment**

- The equipment should be installed near an easily accessible outlet.
- Place the device on a flat, solid and stable surface that can support the weight of at least 3 devices. If you use an unstable cart or stand, the device may fall, causing injury to a child or adult, and serious damage to the device.
- Never use the monitor in the presence of flammable anesthetics mixture with air, oxygen or nitrous oxide.
- Never expose the monitor to rain or moisture. Never use the monitor near water e.g. near a bathtub, washbasin, swimming pool, kitchen sink, laundry tub or in a wet basement.
- Please heed necessary space between the monitor and the wall for ventilation. Do not cover or block any ventilation openings in the cover of the set.
- Keep small object away from the product. If small object gets into the monitor, please shut off power supply immediately and contact us for technical support.

#### About the power and ground

- Please use power cord provided with the monitor, and insert the plug into the socket firmly.







## 3. Monitor installation

### 3.1 Installation instruction



#### **Attention:**

- 1. Make sure that endoscopic host and monitors are powered off.
- 2. Unpack the product and check the accessories according to packing list. Confirm the monitor and accessories are complete.
- Plug one side of the signal wire into monitor's back interface, and the
  other side into endoscopic host's interface, then Tighten the screws.
   E320AG supports wall design, which should withstand the force of
  13kg at least.
- 2. Connect to the operating room grounding system through the PE ground which is on the back of the monitor.
- 3. Connect power adaptor to power wire firstly, and then plug power adaptor into monitor's power input port, finally power LED indicater will turns orange.



#### **Caution**:

- Please use the power cord provided with this monitor. If the power cord is inconsistent with the table below, please contact your supplier. Please make sure the power cord matches the voltage of the power socket and has been approved by and complies with the safety standard of your particular country.
- 2 To avoid risk of electric shock, AC/DC adaptor must only be connected to a power socket with protective earth.

# 4. Monitor settings

#### 4.1 Turn on the monitor

Turn the power on, the power indicator will turn white, and the monitor's screen will display the JUSHA boot screen, indicating that the monitor is running.



#### Warning

- 1. The product has the memory function that can automatically record the shutdown mode after the user's last use. If, after the on-Off key is turned Off, AC power rocker switch is turned Off to shut down the product, the on-Off key has to be turned on to power on the product; If the product is powered Off directly by pressing AC power rocker switch, it is able to directly power on the product after turning on AC power switch, no need for ON/OFF switch operation.
- 2. Restart the product only 4s after directly pressing AC power rocker switch and the indicator is completely off, or otherwise startup abnormality may occur.
- 3. Only the original power cord and adaptor shall be used. Please guarantee the plug can be wholly plugged into the socket. Please guarantee the voltage be lower than nominal voltage of the power line.

### 4.2 Monitor sleep

When the product is turned on, press power switch button to turn off the product, then the power indicator will turn red. Turn off AC switch, power indicator will turn off and then pull off the power socket.

### 4.3 Turn off the monitor

When the product is turned on, press power switch button to turn off the product, then the power indicator will turn red. Turn off AC switch, power indicator will turn off and then pull off the power socket.


### **4.4 Menu Instruction**

## 4.5 Operate OSD menu

#### 4.5.1 Call out menu

When the product is turned on, press any key to call navigation menu, and press , OSD menu appears on the product screen. If the next operation is not performed within 15s, OSD menu will disappear again.

#### 4.5.2 Exit menu

Two methods are available to exit OSD menu:

- 1. On the submenu page, press to return to the previous option of current operation; and then press to exit the menu.
- 2. If no operation is performed within 15s, the menu will automatically disappear.

### 4.5.3 Adjust backlight

- 1. Press any key to call navigation menu, and press to call out menu and by default, [Image] page is displayed firstly.
- 2. Press to move cursor to enter Image submenu.
